APPLICATION FOR A RESEARCH GRANT – CAIS AM GRANT YMCHWIL

Grants are awarded for a variety of research projects each year, as reported in our *Newsletter*, our website (www.cambrians.org.uk), and in *Archaeologia Cambrensis*. A wide range of projects is eligible for funding – excavations, assistance with all aspects of post-excavation work, survey work of all kinds and historical research – within our overall charitable objectives, to ‘examine, preserve and illustrate the ancient monuments and remains of the history, language, manners, customs, arts and industries of Wales and the Marches and to educate the public in such matters’. Sometimes the Association is the sole funder but we look particularly favourably upon applications where our grant forms part of a package of funding. Applications for projects financed by the date, local authorities or to meet planning requirements are not usually considered.

DEADLINES: Please note that grant applications are considered at the Trustees’ Meeting in early November; applications must therefore be submitted **by 15th October**. Applications for which more details are requested, and some new, urgent applications, may be considered at the discretion of the Trustees at their meeting in February, subject to funds remaining for disbursement.
