OPEN ACCESS POLICY

Archaeologia Cambrensis is published annually by the Cambrian Archaeological Association (<http://www.cambrians.org.uk>) and is currently a print-only journal. The journal is peer-reviewed and covers a broad range of multi-disciplinary topics relating to the archaeology and history of Wales and the Marches. ‘Notes for Contributors’ are available on the Cambrians’ website.

Self-archiving

The journal operates a ‘green’ (self-archiving) open access policy which permits authors to make their article available online immediately following publication. Authors are provided with a digital offprint of their article which they are entitled to place online on a freely accessible (personal, institutional, discipline- or subject-specific) website or online repository. No time embargo is imposed and no article processing charges are applied by the publisher. Authors are also entitled to make copies of the digital offprint for circulation but prior permission should be sought from the publisher if authors wish to use the digital offprint for commercial purposes or as a means of republication. (See also note below on copyright.)

Pre-publication

Once an article has been formally accepted for publication, authors are entitled to make an ‘accepted manuscript’ version available online prior to publication. An ‘accepted manuscript’ would typically be the final, copy-edited, pre-press draft of the article, agreed by the author and editor, which incorporates changes suggested during the peer-review process. The volume in which the article will appear and the year of publication would normally have been determined at this stage but since final page numbering would be unknown it will be appropriate to consider the article as ‘forthcoming’ for citation purposes. (See also note below on copyright.)

Copyright

Articles are published on the condition that copyright is held jointly by the Cambrian Archaeological Association and individual authors. If an article includes text or images not in the author’s copyright and not covered by ‘fair use’ or ‘fair dealing’ provisions, it is the author’s responsibility to obtain permission from the relevant copyright owner for permission to reproduce the material worldwide in all forms and media, including electronic publication. Note that illustrative material such as photographs and drawings are not included in ‘fair use’ or ‘fair dealing’ provisions and permission must always be sought for their use in the article. Correspondence relating to the relevant permissions should be submitted to the editor. Unless prior agreement has been reached, the Cambrian Archaeological Association will not be responsible for the payment of any reproduction fees to a third party.

Journal online

Volumes of the journal for 1846–1999, by agreement with the National Library of Wales, can be accessed free of charge on the Welsh Journals Online website (<https://journals.library.wales/>) together with a number of supplementary volumes. Volumes for 2000 onwards are available online on the Archaeology Data Service website (https://archaeologydataservice.ac.uk/archives/view/arch_cambrensis/) with the exception of the three most recent volumes.
